# Design study

## Introduction

This report aims to show the extent to which design protection is used in Denmark compared to other European countries. Design protection is relevant for many enterprises as it protects their products from being copied. It can also help reassure investors that the product they invest in is protected and unique on the market. Design protection can therefore serve as an important strategic tool for many enterprises and their long-term business plans.

Furthermore, studies have shown the importance of design protection in an economic context. Design-intensive industries contributed with 13 pct. of all jobs in the EU in the period 2017-2019<sup>1</sup>. In addition, enterprises with design protection have better economic results than enterprises without IP-protection. One study has shown that enterprises with design protection have 32,3% higher revenue pr. employee compared to enterprises without any IP-rights<sup>2</sup>.

The following report uses design-application data from the European Union Intellectual Property Office (EUIPO) to highlight Danish enterprises' designactivity compared to other European countries in the period 2016-2022<sup>3</sup>.

The results show that Danish enterprises submit more design applications and designs pr. capita than the other countries in the report. Danish enterprises are especially active in the categories 'Furnishing' and 'Articles of adornment' in which 1/3 of all the Danish design applications fall under. This makes it clear that Danish enterprises are especially active in seeking design protection seen from a European perspective.

# What is a registered design?

- A registered design protects the appearance of a product which could be clothes or furniture - but it could also protect part of a product e.g., a pattern or a distinctive feature on a chair.
- To register a design, it must be new and have individual character. Individual character means that the overall impression the design produces on the informed user differs from the overall impression produced on such a user by any design that has been made available to the public before the filing date.
- Design protection can last up to 25 years with possible renewals every 5. years. Design protection of spare parts can last up to 15 years.

# **Denmark's leading position**

Figure 1 shows the total number of design applications filed to EUIPO in the period 2016-2022 from different countries. The total amount of design applications filed by applicants in Germany is close to 4.000 design applications pr. year. This makes it the most design-active country.

In comparison, there is close to 500 Danish design applications pr. year.

In general, the total amount of design applications sent from the different countries have been relatively stable in the period from 2016-2022.

Figure 2 shows the number of design applications pr. million people in the period 2016-2022. Denmark have been the most design-active country as there have been close to 85 Danish design applications pr. year.

It is worth noticing, that a design application can contain up to several designs and a comparison between countries should therefore account for this. Consequently, figure 3 shows that Denmark also have been the most design-active country when considering the number of designs that have been filed pr. million people.

# A closer look at the Danish position

When design applications are submitted to EUIPO they are classified after the Locarnoclassification which is an international classification system administered by World Intellectual Property Organization (WIPO)<sup>4</sup>.

Figure 4 shows the top-10 most used classes in Danish design applications in the period 2016-2022. Figure 4 shows that more than 1/3 of Danish design applications is categorized in the

classes 'Furnishing' and 'Articles of adornment'. The most used class in Germany and Italy is 'Furnishing' while it is "Articles of clothing and haberdashery" in Spain. In Norway the most used class is 'Packaging and containers for the transport or handling of goods' while in Sweden the most used class is "Recording, telecommunication or data processing equipment" (see annex 1).

#### Overview of the most design-active **Danish enterprises**

# Conclusion

The purpose of the report is to show to which extend design applications are used in Denmark. The results show that Danish enterprises are especially active in seeking design protection compared to other European countries. This trend has been stable over the entire period of 2016-2022. In addition, it seems that Danish companies mostly holds strong position in the categories 'Furnishing' or 'Articles of adornment' as about 1/3 of the design applications falls within one of these categories.
